



Fig.1 Ground Emitter Propagation Characteristics





Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)




Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. Emitter Current

Fig.9 Capacitance vs. Reverse Bias Voltage




Fig.10 Collector to base time constance vs. collector current






Fig.11 Noise factor vs.collector current characteristics
