

Description

Block Diagram




Figure 1. Block Diagram




Figure 2. Load Regulation




Figure 4. Dropout Voltage




Figure 3. Adjustment Current





Figure 5. Reference Voltage




 $V_0 = 1.25V (1 + R_2/R_1) + I_{adj}R_2$

3. C_i is required when regulator is located an appreciable distance from power supply filter. C_o is not needed for stability, however, it does improve transient response. Since I_{ADJ} is controlled to less than 100 μ A, the error associated with this term is negligible in most applications.
