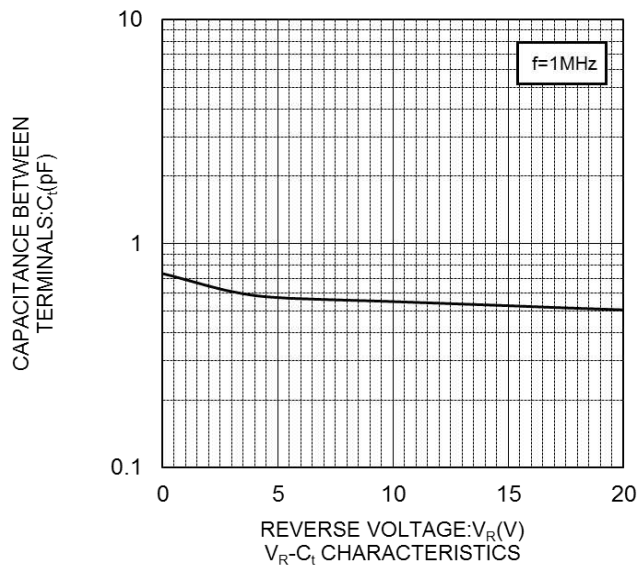
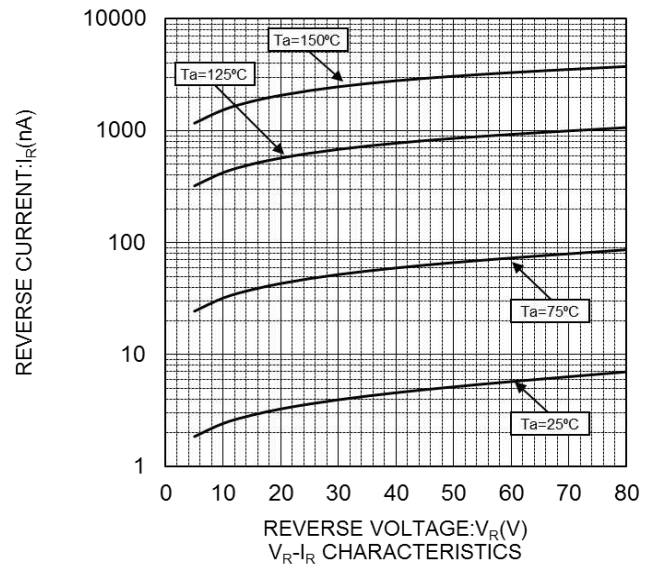
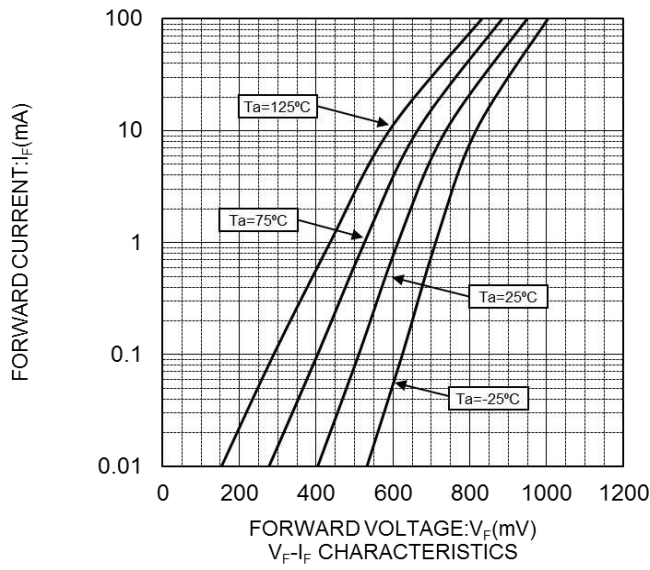
● Inner Circuit



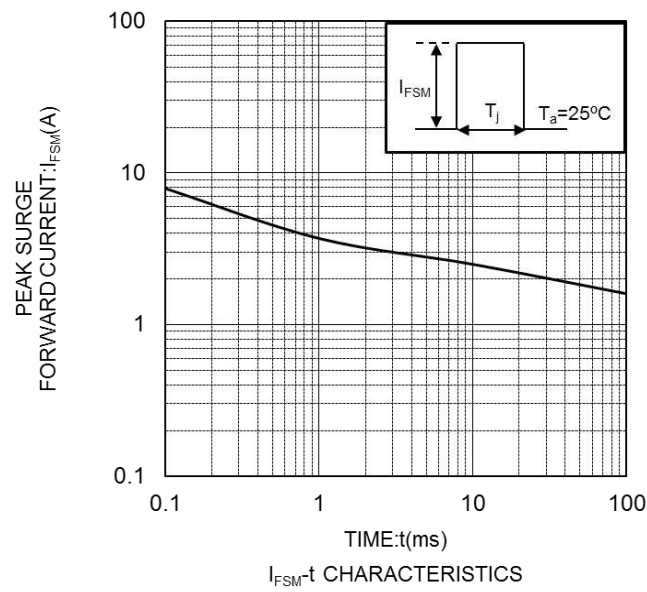
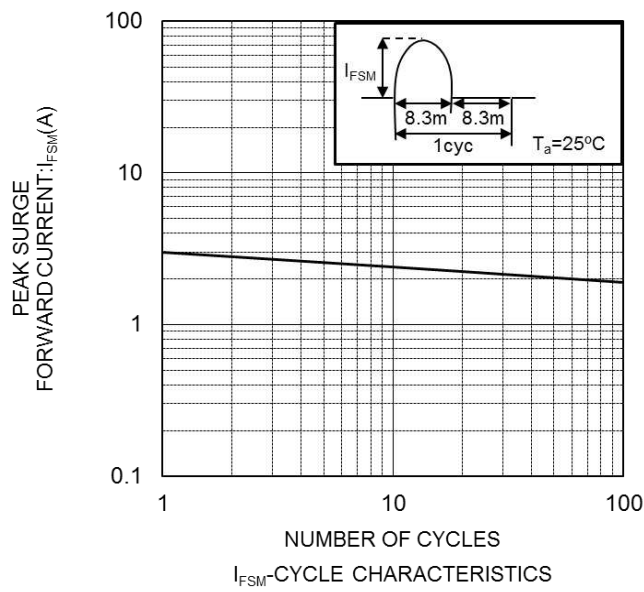

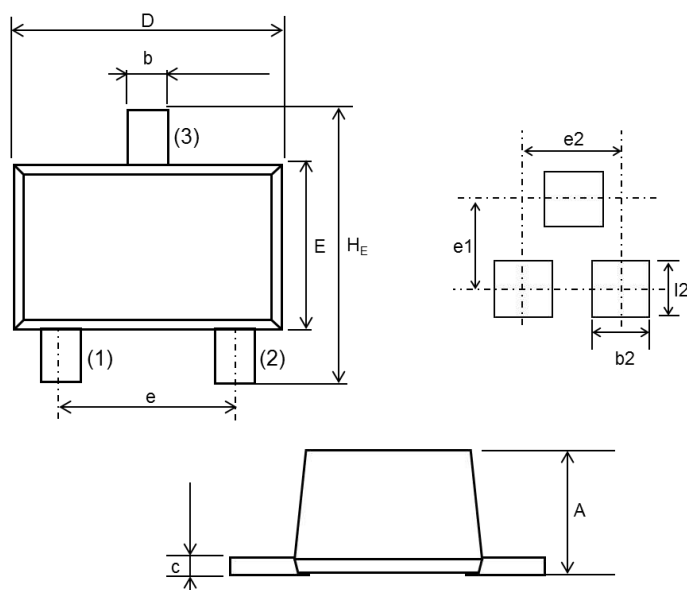
● Characteristic Curves



● Characteristic Curves

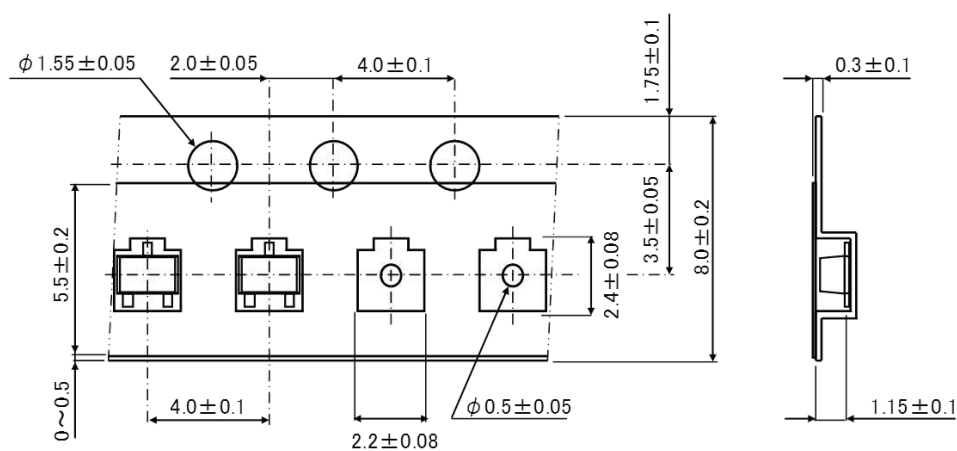
