




4. Functional diagram



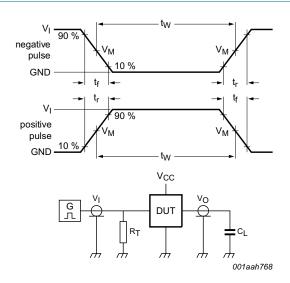

Fig 7. Test circuit for measuring switching times





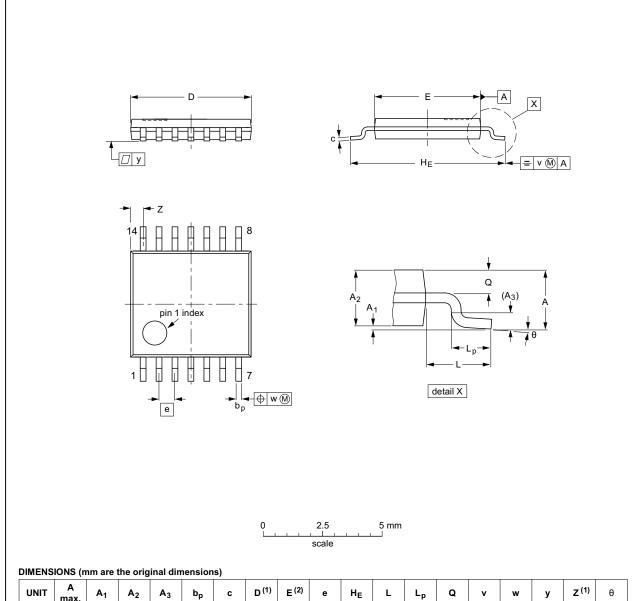
